## First Provisional Merit List of Selected Candidates LL.M. Programme

- The Registration process of Online Counselling for admission to LL.M. Programme at National Law University Delhi was started on Tuesday, December 20, 2022 with last date for Online Counselling Registration as December 26 2022.
- The candidates who registered for the Online Counselling and have paid the Counselling Registration Fee by December 26, 2022 only have been considered in the Provisional Merit List and Waiting List for admission to LL.M. Programme.
- The First Provisional Merit List of Selected Candidate (category wise) for admission to LL.M. Programme is annexed as **ANNEXURE-A**.
- **The candidates who appear in the First Provisional Merit List of Selected Candidates for LL.M. Programme (ANNEXURE-A) should pay a sum of Rs.50,000.00 as “Provisional Admission Confirmation Fee” on or before Wednesday, January 11, 2023 failing which the offer of admission shall stand cancelled and the seat will be offered to the next candidate in order of merit under concerned category from the Waiting List.**
- **The portal/interface for payment of Provisional Admission Confirmation Fee & downloading of Provisional Admission Offer Letter by the provisionally selected candidates will be activated from 2:00 P.M. on Friday, January 6, 2023.**
- In case, the candidates do not accept the offer of provisional admission for any reason whatsoever, it will not be considered afterwards under any circumstances and they will forfeit the right of admission along with the

right to refund the Counselling Fee. No request shall be entertained in this regard.

- The Waiting List has been issued for only those candidates who have participated in the online counselling process. In case, any vacancy arises due to withdrawal of admission or non-payment of **Provisional Admission Confirmation Fee** by the provisionally selected candidates within the stipulated time-period, the seat shall be filled up from the Waiting List candidate(s) only.
- The provisionally selected candidates are also required to download their Provisional Admission Offer Letter from their AILET-2023 account. In token of acceptance of provisional admission offer, the candidate shall sign each page of provisional admission offer letter and upload the same on the AILET-2023 account along-with the undertaking duly signed by the candidate and parents.
- The provisionally selected candidates are also required to upload their Marks Statement of B.A.LL.B.(Hons.)/LL.B. or equivalent examination on their AILET-2023 account. **In case the candidate is appearing in the B.A.LL.B.(Hons.)/LL.B. or equivalent examination in the month of May/June/July 2023, an undertaking is to be uploaded by the such candidates in the proforma provided as ANNEXURE-D**
